GENERAL ORDER 20-03

This Court issues this General Order in response to the recent outbreak of Coronavirus Disease 2019 (COVID-19) in Trumbull County and throughout the State of Ohio. There are multiple confirmed cases of COVID-19, in response to which the Governor of the State of Ohio, Michael DeWine, has declared a state of emergency which, among other things, limits large gatherings. The Governor's Declaration follows the Centers for Disease Control and Prevention ("CDC") "Interim Guidance", recommending that all employers consider how best to decrease the spread of COVID-19, including the review of guidance from state and local health officials.

Given the outbreak of cases of COVID-19 in this County as well as throughout the State of Ohio and the severity of risk posed to the public, and given the CDC mandate and the Governor's Declaration, it is hereby ORDERED that, effective Wednesday, March 18, 2020:

- 1. The use of Someplace Safe / Solace Center for supervised visitation sessions for Trumbull County Domestic Relations / Juvenile Division cases is SUSPENDED UNTIL FURTHER ORDER OF THIS COURT.

4. The parties shall make up this companionship / visitation there by telephone

visitation via FaceTime, Skype, or other video / telephone media or application available.

If that is not available, telephone is acceptable. The visiting party shall initiate the call

and custodial party shall aid in said conference. Conference shall commence and

continue for a reasonable length of time appropriate for the child(ren)'s age(s). Parties

shall act and cooperate with each other in a civilized and polite manner to facilitate these

companionship / visitation sessions.

5. This Order shall be docketed in each of the above-referenced cases and the Clerk

shall issue notice to all parties and counsel in each case.

All until further Order of the Court. IT IS SO ORDERED.
