- Legal aid helps veterans resolve civil legal problems to ensure they have access to safe housing, improved family stability, and increased financial security.

Andrea Conrad* is a proud Army veteran and mother of a 4-year-old. Ms. Conrad worked hard to provide for her child, but during the pandemic, she lost her job and eventually fell behind on her rent. Ms. Conrad's landlord filed an eviction against her. She tried to resolve the matter by applying to Ohio's rental assistance program for help, but she didn't know how to get the money to her landlord. Unsure what to do, she contacted legal aid for help.

Legal aid stepped in and worked with Ms. Conrad's landlord to ensure that the landlord could be made whole and that Ms. Conrad could remain in the apartment. Legal aid also helped Ms. Conrad qualify for two additional months of rental assistance, further benefiting her landlord. Thanks to legal aid, Ms. Conrad's landlord agreed to dismiss the eviction, and Ms. Conrad and her preschooler remain stably housed.
