Important Information Regarding COVID-19 Current as of 3/19/2020 at 1:00 p.m.

As you know, Governor DeWine has declared a state of emergency in Ohio, and the Director of the Ohio Department of Health is limiting gatherings to prevent the spread of COVID-19. Governor DeWine requested that we take decisions that are not only in our own best interest but are also in the best interest of our community.

• On March 18, 2020 Governor DeWine closed several BMV locations around the state. Of Ohio's 186 BMV locations and 57 driver exam stations, a handful will remain open to issue and renew commercial driver licenses and perform commercial knowledge exams to ensure that the transportation of necessaries necessities such as food, medical supplies, and cleaning supplies is not interrupted.

The Central Ohio locations are: Deputy Registrar – 4503 Kenny Road, Columbus 43220 Driver Exam Station – 4738 Cemetery Road, Columbus 43026

• Because of these BMV closures, Governor DeWine announced that he will work with the Ohio General Assembly to extend the expiration date of driver's licenses that are up for renewal, and also waiving required late fees and extending deadlines. In the meantime, the Ohio State Highway Patrol will not issue tickets to drivers whose licenses expire while BMV's services are unavailable. Governor DeWine recommended that other law enforcement agencies in Ohio do the same.

• Ohioans can still renew their vehicle registrations by mail or online at <u>www.oplates.com</u>, and BMV is currently working to provide other online service.

Civil Protection Order Hearings

The Court will continue to receive and conduct hearings on petitions for Domestic Violence Civil Protection Orders (CPO), and will conduct the full hearings on Civil Protection Orders.

Trials, Full Hearings, Final Hearings, Dissolution Hearings, Uncontested Divorce Hearings, and other Evidentiary Hearings

Through April 10, 2020, all trials, full hearings, final hearings, dissolution hearings, uncontested divorce hearings, and other evidentiary hearings (except Civil Protection Order hearings), scheduled to take place at DR Court or with Magistrate Jackson at the Child Support Enforcement Agency will be continued by the Court for a later date.

Pretrial hearings, Settlement Conferences, Status Conferences, and Guardian ad Litem Conferences

Through April 10, 2020, all pretrial hearings, settlement conferences, status conferences and guardian ad litem conferences will be conducted by phone if possible. No Court appearance is necessary. If the judge or magistrate determines that the pretrial issues cannot adequately be addressed by telephone, then the judge or magistrate will continue the conference for a later date.

Filings with the Clerk of Courts

All filing of court documents is required to be done via mail, e-mail, or fax. Except for new Petitions for Civil Protection Orders, no in-person filing options will be available to the public through April 7, 2020. Payment of filing fees will still be required in order for documents to be filed. Notice Regarding Oral Arguments
