## **Legislative News: Two-Week Review**

- <u>HB 2</u> (Reps. Cutrona, Upchurch) **Capital Appropriations**, signed by the Governor 6.28.24. The bill contained funding for many projects including: transitioning the Department of Youth Services to a number of smaller facilities to increase safety and allow for individualized treatment and education; improving the Ohio Fire Academy and State Highway Patrol Crime Lab in anticipation of increased impaired driving because of marijuana legalization; and building local jail facilities.
- <u>HJR 7</u> (Reps. Wiggam, Young) **Constitutional Amendment**, introduced 6.18.24. The resolution proposes to enact Section 5 of Article XV of the Ohio Constitution to prohibit individuals with citizenship in other countries from holding elected public offices.
- <u>HB 639</u> (Rep. Williams) **Aggravated Riot**, introduced 7.9.24. The bill modifies the offense of aggravated riot if the offender is wearing a mask or disguise and requires an additional 1 year prison term for an offender who is convicted of or pleads guilty to a felony if the offender is convicted of or pleads guilty to a specification that the offender wore a mask or disguise in commission of aggravated riot.
- <u>HB 642</u> (Rep. Carruthers) **Adult-Use Hemp Products**, introduced 7.18.24. The bill requires the Director of Agriculture to adopt recommendations regarding adult-use hemp products.
- Changes to the <u>Rules of Practice and Procedure</u> are effective 7.1.24. The <u>amendments</u> include: Revised rules for reopening of an appeal based on ineffective counsel; updates to procedures for serving documents in civil cases; providing a standard for when testimony is "expert testimony"; codifying notification to victims in Juvenile Courts.
- Citizens Not Politicians submitted more than 730,000 signatures on 7.1.24 in an effort to qualify for a proposed redistricting amendment on the November ballot.
- The Center for Jury Studies at the National Center for State Courts is now accepting nominations for the **G. Thomas Munsterman Award for Jury Innovation**. The award recognizes improvements or innovations in jury operations, management or technology. <u>Nominations</u> accepted until 9.13.24.
- Save the Date: The **OJC Annual Meeting** is September 19-20 at the Hilton Columbus at Easton. A total of 10.25 CLEs have been applied for and the agenda includes presentations on Marsy's Law, competency and family law courts, artificial intelligence, working with interpreters, and more.
